Members of the Board,

During the month of July, all regular tasks have been completed. Here is a brief over-view of other tasks performed during the month:

- -Checked the equipment in the Hobart storage garage.
- -We have ordered a new sewer chewer from Koester and Associates for the ARC pump station (budgeted). UPDATE: This has come in. Koester and Associates have started the installation, but need to come back to install the new frame that is needed to complete this. This should be sometime in July. UPDATE: This is scheduled for Wednesday, 8/7.
- -We had Koester and Associates on sight to clean Smith and Loveless pump #2 after noticing that it was having trouble priming.
- -Observed the operation of both pumps at the ARC pump station, all o.k.
- -Prepared and submitted June 2024 monthly report.
- -There was one alarm call for the ARC pump station. Pump #2 had failed to start and went into safety mode. The panel was reset, and the pumps ran as they should.

Duration of this call: 3:15 am to 5:15 am = 2 hrs.

The total flow for the month from South Kortright to the Hobart WWTP was 143,593 gals. with an average of 4,632 GPD.

The total flow from the Hamlet was 147,550 gals. with an average of 4,760 GPD.

The total flow from the Allen Residential Center was 0 gals. with an average of 0 GPD.

## **BUDGETING NOTES:**

As of July 2024, we have used 37.2% of the overall budget.

We are working on the 2025 proposed draft O&M Budget.

Commercial water meter reads are complete for 2025 budgeting.
