> Town of Stamford, South Kortright Sewer District May 2022 Monthly Report

Members of the Board,

During the month of May, all regular tasks have been completed. Here is a brief over-view of other tasks performed during the month:

-I showed the sewer system drawings of the area around the Hidden Inn to the contractor, Rich Tait, as they are working on the parking lots. During this time, I found that they had done repairs to the plumbing in the basement. They had to replace the wastewater lines and had changed it so that all wastewater was going through one line. After checking with engineering, it was determined that the waste containing fats, oils, and grease needed to go through the grease trap and the rest straight to the main. The contractor has agreed to make these changes. The contractor was unaware that the Hidden Inn has a grease trap in place.

-We checked on two dig reports for DSNY.

-Picked up abstracts from town hall and entered to expense tracking.

-Checked the equipment in the Hobart storage garage and exercised the sewer jetter and the auxiliary pump.

-Observed the operation of both pumps at the ARC pump station, all o.k.

-Prepared and submitted April 2022 monthly report.

-Added degreaser to the Hamlet wet well and the ARC wet well.

The total flow for the month from South Kortright to the Hobart WWTP was 128,331 gals. with an average of 4,140 GPD.

The total flow from the Hamlet was 120,468 gals. with an average of 3,886 GPD.

The total flow from the Allen Residential Center was 7,863 gals. with an average of 254 GPD.
